Founded in 1947 and run by the second generation of the Méan family, La Garenne School offers unique integration programmes throughout the academic year to children aged between 5 to 16 years old.

In addition to our full-time school year curriculum, students may also choose to join La Garenne as part of our Integration Programme during our academic year from September to June. This offers them a unique taste of academic and boarding life over a shorter period, after which some may choose to join us at a later stage for the full academic year.

The fees include accommodation (for boarding students), food (lunch & snacks only for day students), full day of ski or schooling & ski/snowboard, ski/snowboard equipment, ski pass, activities, excursions, uniforms, books and school materials, personal laundry and use of the IT network, various taxes and V.A.T.

Transfer from and to Geneva Airport, pocket money and health insurance are not included. Parents are required to provide a copy of an insurance certificate from the country of residence covering care in Switzerland. To ease the parents' organisation, the pocket money will be charged directly in the invoice.

DAY STUDENTS:

Follow the normal curriculum until 16:00.

BOARDER STUDENTS:

Follow the normal curriculum and stay overnight after evening activities.



Application Procedure

1. Please submit an online [Enquiry Form](#) and we will contact you to discuss availability and answer your questions. Submit the Admissions form and supporting documents (copy of passport, vaccination records, etc.) and any academic reports required by the Director of Admissions. 1. If a child is travelling alone by plane, please complete an(Unaccompanied Minor) form for their return journey. The form should include the details of the person who will pick up your child at the destination airport. Passports are required for air travel.

FINANCIAL CONDITIONS

The reservation will only be effective once the entire payment has been settled. If parents cancel their child's place 65 days or fewer prior to the start of the Integration Programme, the school reserves the right to retain the amount paid. Once the Integration Programme has begun, the school retains full payment. This also applies to early or voluntary departure, late arrival, dismissal or prolonged absence.

If there are several boarders from the same family (brothers and sisters) enrolled at the school, the following discount will be applied: 10% for the second child, 15% for the third child, and 20% for the fourth and any additional children. In case of litigation between the school and the parents, Swiss Legislation is the only law applicable in all matters concerning this contract. The competent tribunal will be that of Aigle, Vaud district.

CANCELLATION POLICY

If parents cancel their child's place within 65 days of the start of the course, the school reserves the right to retain the amount paid. Once the course has begun, the school retains full payment. This also applies to early or voluntary departure, late arrival, dismissal, or prolonged absence, or inability to travel because travel documents are out of date or refused at the border.

If a student is prevented from travelling due to worldwide restrictions following declaration of a global pandemic, we either will refund the payment in full or offer a credit note for the amount paid that can be used for any future stay (academic, summer, winter, or integration) valid for two years.
